Aslakson, Vice President & Public Relations

- ◆ Also signs letters for League; approves action plans; correspondence; press releases; testimony made by LWV members, keeps president's files.

Cheney, Finance & Publications

- ◆ Also chairs planning meeting in August; UN Rally; compiles board roster for summer.

Iacono, Treasurer

- ◆ Also compiled board agendas and chaired all board meetings.

Johnson, Voter Service

- ◆ Also received all board mailings and scanned for time sensitive materials; reported essential mailing to board. Distributed mail to board members and copied agendas.

Blake, Unit Organization

- ◆ Also co-signs all checks.

Kobe, Action

- ◆ Also proof reads VOTER.

Karlson, CMAL Representative

- ◆ Also is listed as telephone contact person forwarding calls and information to board members; speaks for league when appropriate; presides at candidate's forums and general meetings.
