GOVERNANCE:

- December Minutes were reviewed and approved. As there was no scheduled meeting in January, and the February meeting was canceled due to weather, no other minutes were reviewed.
- Treasurer's Report: Henry presented his report, strong revenue from a recent membership mailing. A 2019 budget was worked on in the meeting and approved.
- Membership Report: A membership renewal letter was sent to 337 current and former members in early February, which resulted in 85 renewals so far. Additional members had paid prior to the letter, and there are other members who are still current from their 2018 donations. Membership is currently at 208. Another mailing is expected in a few months.
- *Park History Today*: Ted shared that he will send the email newsletter out soon as a follow up to the membership renewal letter as well as to highlight recent research from Mark Toretsky and mention the recent community engagement activities.
- Re-Echo Update: Bill shared that he has a schedule for all 4 issues, with the next issue on track.
- Admin: Ted noted that the agenda will now be organized according to the Societies 3 key strategic pillars: Preserve & Highlight History, Community Engagement, and Education & Programming.

PRESERVE & HIGHLIGHT HISTORY

SLP History Booklet

Bill Beyer presented a project idea in which he would write a 40+ page booklet about the history of St. Louis Park. He would source his material from our website, past SLP history books, and some original research. The format would be like a long form magazine, with pictures and maps, and short pieces of narrative. There will be 10-15 chapters including topics like "Land & Water", "Schools", "Rails and Trails". The intent is to provide an updated overview of the city history that is approachable rather than exhaustive. Bill estimates at a high quantity we could print them at about \$2 each, and if we sold them

at \$10 each it could be a significant fundraiser. In addition, we can coordinate the publication with the 50th anniversary of the Depot being put on the National Register, on November 25th and have a celebration.

Ted put forth the following motion, Jim seconded, all approved: "The Board enthusiastically supports Bill Beyer's efforts to create a new St. Louis Park history booklet, expects to provide input, but authorizes Bill to be the editor, and upon Board approval of final copy authorizes to spend up to \$5,000 to print copies and sell them individually at a price to be determined later."

Archives Training

Kathy Johnson has agreed to train the Board on how to properly log in any archive donation into Past Perfect and discuss proper storage. Training will be on Saturday March 16th during office hours, starting at 1pm.

Mark Toretsky's Research

Ted shared recent research that member Mark Toretsky finished. He researched the buildings around Louisiana and Cedar Lake Rd. and determined the date each was built. He also has finished updating a list of the 350+ stores that have ever been located in Knollwood mall and their associated dates of operation. This information will now get updated on the website by Ted.
